First Amendment to the Regulations for Conducting the Entrance Examination for Vocationally Qualified Applicants as well as for Conducting the Trial Period of Study – Entrance Examination Regulations – Dated November 8, 2021

Based on Section 2(4) in conjunction with Section 49(6) of the Act on the Higher Education Institutions of the State of North Rhine-Westphalia (Higher Education Act – HG) dated September 16, 2014 (GV. NW (Law and Ordinance Gazette of the Land North Rhine-Westphalia) 2014 p. 547), last amended by the Act Regarding Further Measures for Combating the COVID Pandemic in Higher Education Sector dated December 1, 2020 (GV. NRW. p. 1110) and the Ordinance for University Admission for the Vocationally Qualified (Regulations on Admission to Higher Education for the Vocationally Qualified, BBHZVO) dated October 7, 2016 (GV. NRW. 2016 p. 837), Hamm-Lippstadt University of Applied Sciences has issued the following amendment to the regulations:

Article 1 Amendments

The following Sentences 3 and 4 shall be added to Section 4(1):

The examination can additionally be offered in parallel as an online examination. The university management of the executing university decides on this additional offering.

Article 2 Entry into Force, Note Pursuant to Section 12(5)

- (1) This amendment to the entrance examination regulations enters into force on the day after its publication and will be published in the Official Notices of Hamm-Lippstadt University of Applied Sciences.
- (2) It is hereby pointed out that pursuant to Section 12(5) of the Act on the Higher Education Institutions of the State of North Rhine-Westphalia (Higher Education Act – HG) any claims arising from an infringement of procedural or formal requirements of the regulatory law or of any other autonomous law of the higher education institution may no longer be claimed upon expiration of one year after promulgation of this notice, unless
 1. the regulations have not been properly published,
 2. the Presidential Committee had previously raised an objection to the resolution of the body that decreed the regulation,
 3. the formal or procedural deficiency was reported to the university beforehand indicating the violated legal provision and the fact giving rise to the deficiency, or
 4. in the public announcement of the regulation, no reference was made to the legal consequence of the exclusion of complaints.
